
On November 25, 2025, the Arizona Department of Water Resources (“ADWR”) filed a draft abstract for potential water right #111-19-066-SP002 as researched in Watershed File Report #111-19-066. In the report accompanying the draft abstract ADWR noted a issue with respect to property versus water right ownership, and evidence to support a 1916 priority date.


