19 DESCRIPTIVE SUMMARY: This order denies the request to stay, vacates the current trial
20 schedule, and requests a revised timeline no later than **November 10, 2025**.

22 On September 5, 2025, the United States filed a Motion for Stay (“Stay”), to “focus
23 on amicably resolving [statement of claimant] SOC #39-13611.” Amicable negotiations
24 are supported; however, an open-ended Stay is not.

25 **IT IS ORDERED** denying the Motion to Stay.

26 **IT IS FURTHER ORDERED** vacating the current trial schedule so that the parties
27 may focus on negotiations for SOC #39-13611.

28 **IT IS FURTHER ORDERED** the parties shall file a joint revised trial schedule no

1 later than **November 10, 2025**. This schedule should not move the trial out more than four
2 months (August 2024) unless further explanation is provided.
