On April 29, 2026, Arizona Adjudications Project with the University of Arizona’s Natural Resource Use and Management Clinic (“Project”) filed a Status Report that included a request for guidance on when claimants should file updated statements of claimant (“SOCs”). The Project indicated that Arizona Department of Water Resources (“ADWR”) recommended waiting until after the Certificate of Water Right has been issued. The Special Master agrees.

IT IS ORDERED claimants shall file final SOCs AFTER a Certificate of Water Right has been issued and vacating any previous deadlines for filing final SOCs.
