22 On November 11, 2024, the Special Water Master ordered the estate of Keith
23 Dinwiddie and Ms. Lupita Dinwiddie to each file a separate status report by January 31,
24 2025. Both parties timely responded. Counsel for Shelly Scriven, Personal
25 Representative of the estate of Keith Dinwiddie indicated at least six months would be
26 necessary for any resolution.

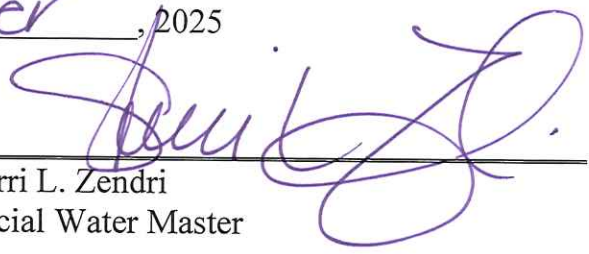
27 **IT IS ORDERED** that the estate of Keith Dinwiddie and Ms. Lupita Dinwiddie

1 progress regarding the resolution of the property ownership including identification of
2 remaining obstacles.

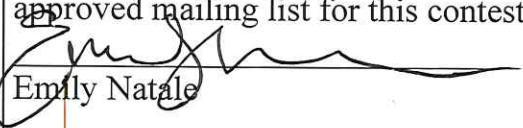
3 **IT IS FURTHER ORDERED** that each party shall file subsequent status reports
