
CONTESTED CASE NAME: *In re Edgar and Lorraine Dinwiddie*

DESCRIPTIVE SUMMARY: This order sets a **June 19, 2026**, deadline for parties to file a status report and reminds the estate of Keith Dinwiddie and Ms. Lupita Dinwiddie to each file a separate status report with the Court **every 60 days** until the property dispute is resolved.

On October 21, 2025, the Special Water Master ordered the estate of Keith Dinwiddie and Ms. Lupita Dinwiddie to each file a separate status report by December 19, 2025, and then **every 60 days** thereafter until resolution of their property dispute. Both parties filed a status report before December 19, 2025. However, since December, no additional updates have been provided to the Court.


IT IS ORDERED that the estate of Keith Dinwiddie and Ms. Lupita Dinwiddie

1 shall each file a separate status report with the Court by **June 19, 2026**, explaining why
2 they have not been filing periodic status reports as previously ordered and providing the
3 Court with an update on the resolution of the property ownership.

4 **IT IS FURTHER ORDERED** that each party shall file subsequent status reports
5 **every 60 days** thereafter until resolution of their property dispute. Failure to file timely
6 updates may result in removal from this contested case and loss of any potential water
7 rights.
