11:30 a.m. This is the time set for a Status Conference to determine if the landowners are interested in pursuing potential water rights before Special Water Master Sherri Zendri.

Discussion is held regarding Mr. Vargas and Ms. Mendoza's letters of interest.

IT IS ORDERED adding Alicia Bell Mendoza, Augustine E. Vargas, and David M. Rabb, as representative of R Family Ranch, to the Court Approved Mailing List ("CAML").

The Special Master inquires if there is a stockpond.

Ms. Nelson states that there is half of a stockpond on their property and the other half is on Mr. Madsen's property, but it is dried up and not in use. She further clarifies that they use a water company and not a well.

Mr. Rabb states that he has two full stockponds (centrally located, slightly to the North) and a well on his property. He does not know if the stockponds are registered.

Ms. Mendoza and Mr. Vargas state that they are on a split well share with Ms. Bays, the Castagnos and the Ochoas. They believe the well was drilled in 2021.

The Special Master advises the parties that since the well is out of the subflow zone, these parties will not be required to actively participate in this particular adjudication. Ms. Nelson will remain on the list for this adjudication due to the stockpond on her property.

Counsel Wilkinson inquires if this matter will be stayed pending the completion of the depletion test. The case will not be stayed due to R Family Ranch and possibly Ms. Nelson's half of the stockpond.

Discussion is held regarding the San Pedro HSR. The Special Master has not made a final determination as to wells out of the subflow zone and anticipates having a larger discussion at a later time.

Mr. Rabb clarifies that he really only has one stockpond and not two but it is pinched in the middle.

The Special Master addresses Mr. Rabb regarding pre-1919 use. He is encouraged to schedule a meeting with ADWR to discuss his options:

LET THE RECORD REFLECT that Mr. Rabb provides his email to Counsel Nielsen so she may research his parcel to see if there any existing claims.

IT IS ORDERED that ADWR file an update as to the stockponds on the Nelson/Madsen and Rabb properties on or before **January 30, 2025.** The Court will provide further instruction to the parties as to any deadlines, next hearings dates, etc. once the update is received.

The Mendoza, Mr. Vargas, Bays, Castagnos, Ochoas are using a well drilled around 2021. Given the distance of this well from the subflow zone, and the late date at which it was drilled, any potential water rights associated with this well cannot be adjudicated until a subflow depletion test is completed and ADWR investigates water uses initiated after 1991. Mr. Redey currently has no well or surface water sources on his property. Accordingly,

IT IS ORDERED removing the Mendozas, Mr. Vargas, the Bays, the Castagnos, the Ochoas, and Mr. Redey from the Court-approved mailing list for this contested case.

David M. Rabb of R Family Ranch is the remaining claimant for W1-11-001538. Gerald and Phyllis Nelson are claimants for W1-11-001540. Because each contested case still has one active claimant, the cases will continue to proceed concurrently.
