DESCRIPTIVE SUMMARY: This order dismisses this contested case.

During a September 18, 2025, status conference for this contested case, property owners Phyllis Nelson (Cochise County Parcel #124-06-002) and Jared Madsen (Cochise County Parcel #124-02-010Z) indicated there is a single stockpond across both of their properties that is no longer in use. Statement of Claim #36-66720, filed in 1978, appears to be related to this stockpond. Watershed file report (“WFR”) #112-16-008 for this contested case reference Statement of Claim #36-66720 as the basis of right for the potential water rights claimed and investigated by the WFR. In a January 27, 2026, status report, the Arizona Department of Water Resources (“ADWR”) notes that neither property owner has filed assignments or amendments related to this Statement of Claim or the original Statement of Claimant (“SOC”) #39-4034. This stockpond was the only potential

1 water right ADWR associated with this WFR. It is understood that municipal water  
2 is provided to the properties.

3 **IT IS ORDERED** dismissing SOC #39-4034. Because no indication has  
4 been offered to the Special Master of potential claims for any other appropriable  
5 water on the Nelson or Madsen properties, no further action will be taken with  
6 respect to WFR #112-16-008.


7 **IT IS FURTHER ORDERED** dismissing contested case W1-11-001540.
