CONTESTED CASE NAME: *In re Rancho Rio Vista Inc.*

DESCRIPTIVE SUMMARY: This order approves the ADWR recommendation to file updates Statements of Claimant after issuance of a Certificate of Water Right, and sets a **October 30, 2026** deadline for the claimants to file a status report with the Court.

On April 29, 2026, Arizona Adjudications Project with the University of Arizona’s Natural Resource Use and Management Clinic (“Project”) filed a Status Report that included a request for guidance on when claimants should file updated statements of claimant (“SOCs”). The Project indicated that Arizona Department of Water Resources (“ADWR”) recommended waiting until the Certificate of Water Right is issued. The Special Master agrees.

IT IS ORDERED claimants shall file final SOCs AFTER a Certificate of Water Right is issued and vacating any previous deadlines for filing final SOCs.

IT IS FURTHER ORDERED claimants shall file a status report with the Court
