

This contested case was initiated November 25, 2024, and the initial status conference was held on January 7, 2025. Current property owner, Augustine E. Avechuco, initially expressed interest in pursuing any potential water rights for Pinal County tax parcels 306-13-076 and 306-13-077. However, when Mr. Avechuco failed to attend a January 29, 2026, status conference to update the Special Master on the progress of his permit application, he was ordered to file a notice with the Court no later than February 28, 2026, indicating if he was still interested in pursuing any potential water rights he may have for Pinal County tax parcels 306-13-076 and 306-13-077. As of the date of this order, the Court has received nothing from Mr. Avechuso. Therefore,


IT IS ORDERED dismissing this contested case and no further action will be taken regarding WFR 113-04-DC-020.
