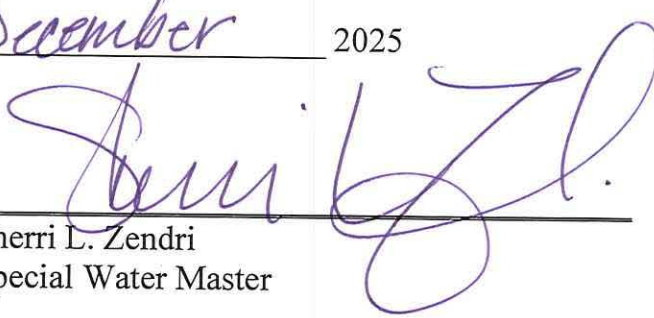
25 According to ADWR's licensing timeframe rules, applications for a permit to
26 appropriate water, or a "33-filing" may take over a year to complete processing.
27 However, it is hoped the relatively simple application for wells located in the subflow
28 zone may take less time.

1 **IT IS ORDERED** that by **June 19, 2026**, all property owners associated with
2 these two contested cases, Patricia A. and George E. Garcia (W1-11-002396), and
3 Augustine E. Vargas (W1-11-002396), Carlos and Gilda Marquez (W1-11-002397),

7 single status report that addresses all applications in process.

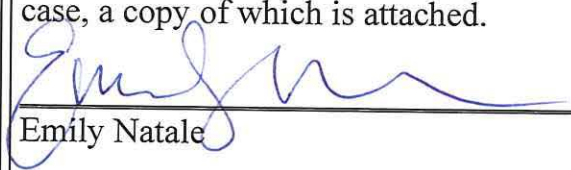
