The Special Master addresses the parties regarding a small administrative change in the contested case numbers. The parties are advised that moving forward, all contested cases in regards to the general adjudication of all rights to use water in the Gila River System and Source will have two leading zeros, i.e. W1-11-2396 will become W1-11-002396 and W1-11-2397 will become W1-11-002397.

The Court notes that it received an updated map and inquires if the property owners would like to proceed.

Augustine Vargas, Pat Garcia, Arthur Verdugo, Gilda Marquez and Carlos Marquez all indicate that they would like to proceed.

Mr. Vargas informs the Special Master that his well was drilled in 2006 and inquires if the correct well, no. 55-904301 is included in this litigation.

The Special Master will provide further guidance after hearing from the rest of the parties.

Mr. Verdugo and Mr. Marquez both believe they have filed and paid.

Counsel Nielsen provides an update. They have received 33 filings from Carlos and Gilda Marquez, Arthur Verdugo Jr. Properties LLC, and Arthur and Oliva Verdugo. The administrative review period will be finished next week and they will be informed if there are any missing documents. Patricia Garcia and Augustine Vargas also both submitted applications but she does not have any further update on those.

Ms. Garcia inquires if ADWR will be maintaining the wells once this is over. The Special Master clarifies that no one is trying to take any water rights away and reiterates the purpose of this adjudication.

LET THE RECORD REFLECT that Ms. Garcia's daughter, Grace, provides an email to the Special Master and requests to be added to the email list for this contested case.

The Special Master calls for any additional comments or concerns.

Mr. Verdugo states he has nothing further to add but would like to note that they appreciate ADWR's staff as they have been extremely helpful to him and the Marquez family with this process.

IT IS ORDERED that ADWR shall provide Notice whether the property owner's applications are complete or if there has been a request for additional information and the anticipated timeframes for completion on or before **November 21, 2025**. Once the Special Master receives this information the parties will be advised of the next steps through a separate order.
