**ORDER TO AMEND STATEMENT OF  
CLAIMANT AND FILE REVISED  
DRAFT ABSTRACT**

CONTESTED CASE NAME: *In re K.J. Smallhouse*  
HSR INVOLVED: San Pedro Hydrographic Survey.  
DESCRIPTIVE SUMMARY: Claimants are ordered to file a statement of claimant amendment no later than **June 8, 2026**. The Arizona Department of Water Resources is ordered to file a revised draft abstract no later than **July 31, 2026**.

On April 1, 2026, claimant Bayless & Berkalew Co. filed a draft abstract for potential water right #113-09-023-SW001. Comments were received from the Arizona Department of Water Resources (“ADWR”) and the San Carlos Apache Tribe (“Tribe”). ADWR and the Tribe noted inconsistencies between the proposed abstract and the statement of claimant (“SOC”) amendments filed in 1987 and 1988.


**IT IS ORDERED** that Bayless & Berkalew Co. shall file no later than **June 8, 2026**, an amendment to SOC 39-3536 that clearly and conclusively resolves any discrepancies between the original SOC, the 1987 and 1988 SOC amendments, the basis

1 of right (36-67624), and the proposed abstract.

2 **IT IS FURTHER ORDERED** that Bayless & Berkalew Co. shall confirm with  
3 the Court no later than **June 1, 2026**, their withdrawal of SOC 39-14028.

4 **IT IS FURTHER ORDERED** that ADWR shall file no later than **July 31, 2026**,  
5 a draft abstract for potential water right 113-09-023-SW001, that incorporates the  
6 information from the final amendment to SOC 39-3536, as well as ADWR's comments  
7 regarding numbering of the SOC and basis of right. ADWR shall also update the map in  
8 accordance with the agency's template.
