**ORDER FOR STATUS REPORT**

16 **DESCRIPTIVE SUMMARY:** The Order sets a deadline for the Arizona Department of  
17 Water Resources to file an update with the Special Master no later than **February 6,**  
18 **2026.**

19 During the October 16, 2025, status conference, property owner Judith Dykes was  
20 ordered to meet with the Arizona Department of Water Resources (“ADWR”) by the end  
21 of December 2025, and ADWR was ordered to file a summary of the meeting within 10  
22 business days. On October 28, 2025, ADWR filed a meeting summary for an October  
23 27, 2025, meeting between the agency and Ms. Dykes. The response time of both Ms.  
24 Dykes and ADWR is recognized and appreciated. The minute entry from the October  
25 16, 2025, meeting, filed October 21, 2025, further instructed ADWR to include an  
26 estimated time frame for ADWR to complete the processing of any filings from Ms.  
27 Dykes. While it is understood that the exact date of completion is unknown, for case

1 management an estimate is necessary to keep the case moving.


2 **THEREFORE, IT IS ORDERED** that no later than **February 6, 2026**, ADWR  
3 shall file a status report that includes an estimated time frame for ADWR to complete the  
4 processing of any filings from Ms. Dykes, including a schedule for filing periodic updates  
5 to the Special Master until processing is completed.
