26	This order opens a case to determ	nine rights to use water on land owned by the					
27	Arizona Game and Fish Commission.						
28	In this case, Arizona State Land Department ("ASLD") filed Statement of						

Claimant ("SOC") 39-6815. The SOC contains a stock watering claim. The Arizona Department of Water Resources ("ADWR") investigated the claim and prepared Watershed File Report ("WFR") 114-04-020, published in the Final San Pedro Watershed Hydrographic Survey Report (1991) ("HSR"). A copy of the WFR is attached as Attachment A. After ADWR issued the WFR, objections were filed to the findings made in the WFR by ASLD, the Gila River Indian Community, the San Carlos Apache Tribe, Tonto Apache Tribe, and the Yavapai-Apache Nation.

Claimant and Landowners

WFR 114-04-020 lists John and Mary Lou Smith as the owner of the land investigated: Pinal County parcel 300-33-0040. Pinal County Assessor records indicate that the property is currently owned by the Arizona Game and Fish Commission ("AGFC"). A map depicting the area investigated in the WFR is attached as Attachment B. ASLD appears to have attempted to withdraw SOC 39-6815 when the agency filed their objections to WFR 114-04-020. However, the public records of ADWR for SOC 39-6815 include an amendment to the SOC filed by ASLD. ADWR records do not contain any assignments of the SOC listed in the WFR, nor does it appear anyone else has filed any additional SOCs since the issuance of the 1991 HSR.

IT IS ORDERED:

- **1. Case Initiation.** This order initiates contested case W1-11-002870.
- 2. **Declaration.** ASLD and AGFC shall review the SOCs relevant to this contested case and jointly declare to the Court by **December 1, 2025,** any claims the State of Arizona intends to pursue in this contested case, and which agency will be pursuing the claims.
- **3. Assignments.** If AGFC intends to pursue the claims, any appropriate assignments of SOCs and legal basis of right to water relevant to this contested

case shall be filed by January 2, 2026.

- **4. Draft Abstracts.** The agency intending to pursue claims as noticed to the Court in #1 above shall file draft abstracts for claims eligible for summary adjudication by **January 30, 2026.** The objecting parties shall file any comments to the draft abstracts by **February 13, 2026.**
- **5. Parties.** The litigants in this contested case are the current landowner, lessees, and all parties who filed objections to the Watershed File Report. The objectors are ASLD, the Gila River Indian Community, the San Carlos Apache Tribe, Tonto Apache Tribe and the Yavapai-Apache Nation.
- **6. Objections.** Copies of objections filed to this case can be found under the respective case names and numbers on the following website: http://www.superiorcourt.maricopa.gov/SuperiorCourt/GeneralStreamAdjudication/whatsNew.asp.

7. Court-Approved Mailing List.

- A. The initial Court-approved mailing list for this case shall include all persons listed on Attachment C to this order. The list may be modified only by filing a motion with the Special Master to amend the Court-approved mailing list. Litigants are responsible for using the current Court-approved mailing list.
- **B**. A copy of any pleading filed with the Clerk of the Maricopa County Superior Court in this case shall be served upon each person listed on the Courtapproved mailing list.
- C. Claimants wishing to be added or removed from the mailing list shall file a motion with the Special Master. Parties allowed to intervene will be automatically added to the Court-approved mailing list.
- **D**. The Clerk of the Court will send copies of all minute entries and orders issued in this case to the parties listed on the Court-approved mailing list.


