On October 28, 2025, counsel for Mark Barron filed a status report indicating Mr. Barron had properly registered his well, filed a Statement of Claimant for his domestic use, and filed a Statement of Claim of Right to use Public Waters of the State of Arizona. It is unclear whether the Arizona Department of Water Resources (“ADWR”) has completed processing of Mr. Barron’s Statement of Claim, however the claim was filed nearly four months ago.

**IT IS ORDERED** that ADWR file a draft abstract no later than **April 6, 2026**, for

2 003 and supported by his most recent filings outlined above.
