On June 4, 2019, proposed abstracts for potential water rights (“PWR”) 115-04-ADB-002-IR001, 115-04-ADB-002-OT001, and 115-04-ADB-002-DM001 were included in the Catalog of Proposed Water Rights created pursuant to § 15 of the Rules for Proceedings Before the Special Master. On May 15, 2023, a petition was filed to have the proposed abstracts assigned to the new property owners, Leo B. and Elizabeth A. Christensen. At that time the Court was in receipt of other transfer requests, therefore the Special Master postponed any decision until after Judge Blaney determined jurisdiction over “post-abstract severances and transfers.”


On October 3, 2023, the Special Master received a Notice of Substitution of Parties and Withdrawal of Counsel indicating that the property associated with this

1 contested case had again been transferred, now to Aravaipa Rec Properties LLP.


2 For simple ownership transfers, where there are no other changes to any PWR
3 attributes, the Special Master must be presented with evidence that the statement of
4 claimant and any basis of right for the PWR have been properly assigned to the new
5 property owner through the Arizona Department of Water Resources.

6 **IT IS ORDERED** that if Aravaipa Rec Properties, LLP, as the new property
7 owner for Pinal County tax parcels 300-29-001D, E, and F (formerly #300-29-001A),
8 seek assignment of the approved proposed abstracts, evidence of proper assignments of
9 statement of claimant #39-6579, statement of claim #36-68562, and any appropriate well
10 registrations must be filed no later than **May 1, 2026**.
