HSR INVOLVED: San Pedro Hydrographic Survey.  
DESCRIPTIVE SUMMARY: The Clerk of the Maricopa County Superior Court is directed to initiate W1-11-003347. Arizona State Land Department shall file with the Special Master a statement declaring the claims that it intends to pursue no later than **June 5, 2026**, and file draft abstracts no later than **July 6, 2026**. Comments to the abstracts must be filed no later than **July 20, 2026**.

**General Explanation**

This order opens a case to determine rights to use water on land owned by the Arizona State Land Department (“ASLD”).

In this case, ASLD filed statement of claimant (“SOC”) 39-6757. The Arizona Department of Water Resources (“ADWR”) investigated the claims and prepared watershed file report (“WFR”) 115-05-024, published in the San Pedro River

1 Hydrographic Survey Report (“HSR”). A copy of the WFR is attached as Attachment A.  
2 A map illustrating the area investigated in the WFR is attached as Attachment B. The  
3 WFR describes a stock watering use.

4 After ADWR issued the WFR, objections were filed to the findings made in the  
5 WFR by ASLD, Gila River Indian Community, San Carlos Apache Tribe, Tonto Apache  
6 Tribe and the Yavapai-Apache Nation.

### 7 **Claimant and Landowners**

8 WFR 115-05-024 lists ASLD as the owner of the land investigated. ASLD records  
9 indicate that the property investigated currently comprises ASLD parcel 05-105998. The  
10 public records of ADWR do not contain any assignments of the SOC listed in the WFR.  
11 Further, neither the state nor lessees appear to have filed any additional SOCs since the  
12 issuance of the HSR.


### 13 **IT IS ORDERED:**

- 14 **1. Case Initiation.** This order initiates contested case W1-11-003347.
- 15 **2. Declaration.** ASLD shall review all SOCs relevant to this contested case and  
16 declare to the Court no later than **June 5, 2026**, the claims that it intends to  
17 pursue in this contested case.
- 18 **3. Draft Abstracts.** ASLD shall file draft abstracts for claims eligible for summary  
19 adjudication no later than **July 6, 2026**. The Parties shall file any comments to  
20 the draft abstracts by no later than **July 20, 2026**.
- 21 **4. Parties.** The litigants in this contested case are the current landowner, lessees,  
22 and all parties who filed objections to the watershed file report. The objectors  
23 are ASLD, Gila River Indian Community, San Carlos Apache Tribe, Tonto  
24 Apache Tribe and the Yavapai-Apache Nation.

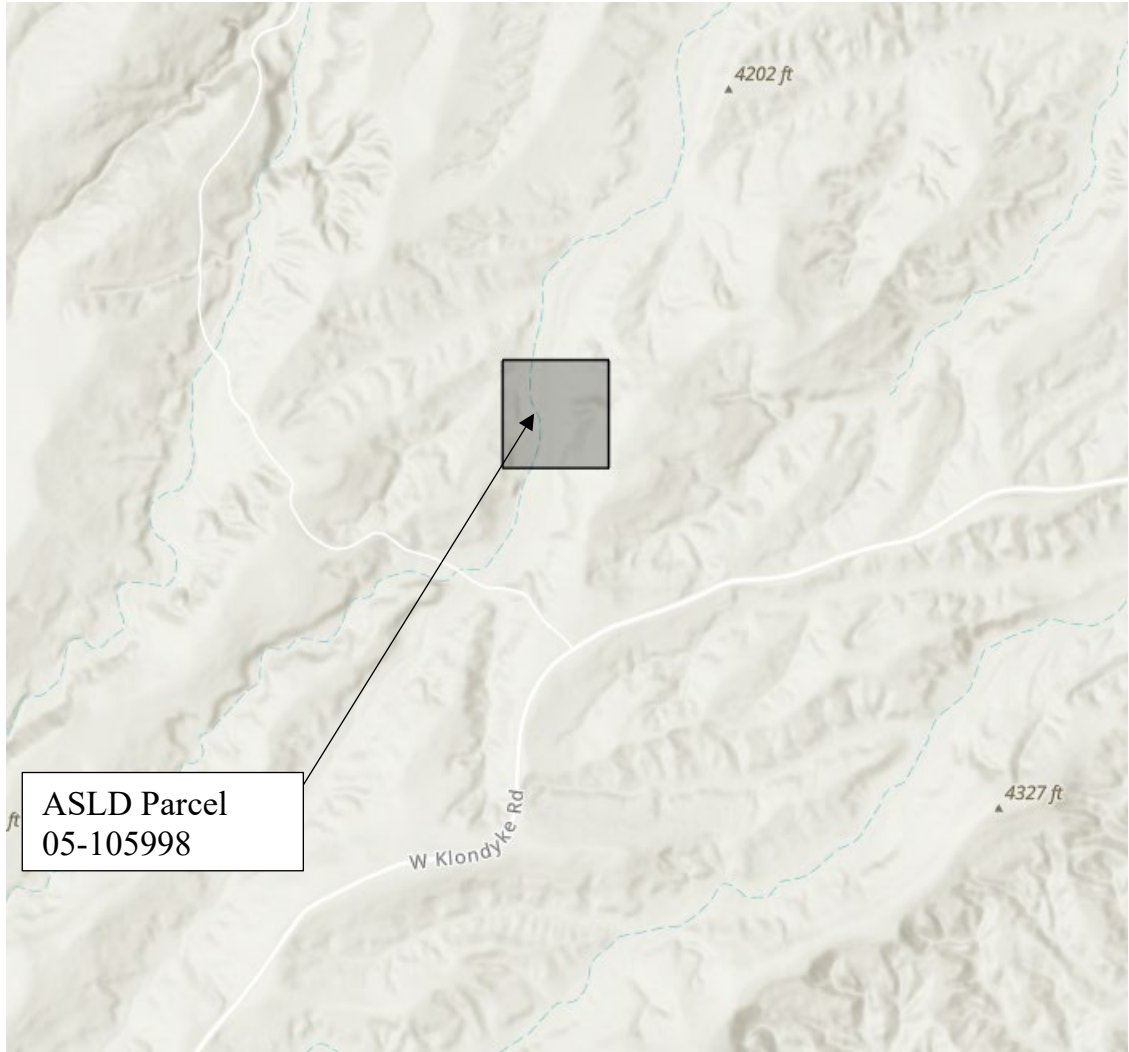
