**ORDER CORRECTING THE JUNE 13,  
2025, ORDER TO UPDATE CLAIMS**

14 **CONTESTED CASE NAME:** *In re James F. Maloney and Patricia M. Matrecito*

15 **HSR INVOLVED:** San Pedro Hydrographic Survey.

16 **DESCRIPTIVE SUMMARY:** The Court's June 13, 2025, Order is corrected to remove  
17 the deadline to file necessary "pre-adjudication documents."

18 **NUMBER OF PAGES:** 4

19 On June 13, 2025, the Court issued an order directing the Matrecito Family  
20 Revocable Trust ("the Trust") to "file by September 12, 2025, Statements of Claimant  
21 reflecting current property ownership and water use."<sup>1</sup> The Order also required the Trust  
22 to file "necessary 'pre-adjudication documents' (e.g. stockpond claims of right or  
23 applications for a permit to appropriate public water) with ADWR by September 12,  
24 2025."<sup>2</sup>

25 **IT IS ORDERED** correcting the Order dated June 13, 2025, to remove the  
26 following: "Further, if the Trust intends to claim water rights initiated after 1919, the
