25 that had been ordered from the National Archives on January 19, 2023. The Court has
26 received no further communication from the parties regarding the order of documents from
27 the National Archives or any other update.

1 This case was initiated on October 10, 2022 and was originally stayed due to the
2 closure of the National Archives on March 20, 2023. The Court has allowed counsel ample
3 time to research and gather documentation to move this case forward. It has been ten (10)
4 months since the parties have given any update to the Court.

11 dismissed unless good cause can be shown otherwise.
