On March 1, 2023, counsel for Charles T. Cleveland filed a Status Report which stated that draft abstracts had been distributed to the parties. According to the Status Report all objectors, with one exception, have either approved the draft abstracts or were in the process of obtaining approval of the abstracts. The Gila River Indian Community has neither provided

1 comments on the circulated abstracts nor approved the draft abstracts. By Order dated January
2 3, 2023, the Gila River Indian Community was instructed to either approve the draft abstracts
3 or provide its comments to counsel for Charles T. Cleveland about the draft abstracts by
4 February 15, 2023.

6 **IT IS FURTHER ORDERED** that counsel for Charles T. Cleveland shall file
7 stipulated abstracts with the Court no later than **March 15, 2023**. If no agreement can be
8 reached on the objections by the parties, a Scheduling Conference shall be held on **March 17,**
9 **2023 at 3:00 p.m.** If the Gila River Community has not either approved the abstracts or
10 provided comments to counsel for Charles T. Cleveland by March 15, 2023, counsel for Gila
11 River Community shall be prepared to show cause why the objections filed by the Gila River
12 Community should not be dismissed due to repeated failure to timely comply with issued
13 orders. The Scheduling Conference will be held using the Court Connect program. Instructions
