The Court has received the position paper of the United States.

The Court inquires of Mr. Brown as to the status of a stipulation to abstracts for water rights.

Mr. Brown states that a conference call with the United States was held and documents were provided. He has no objection to the United States' participation in this matter.

The Court inquires if an agreement has been reached with all other parties except the United States?

Mr. Brown states that an agreement is close and they expect to meet the December 1, 2022 deadline.

The Court inquires of Ms. Staloff as to how long she will need to respond to the proposed stipulation.

Ms. Staloff would like until February due to the upcoming holidays. They would like to carefully review all of the documents and what has happened in the case so far.

- Mr. Sparks states that there is one outstanding issue.
- Mr. Foy received the abstracts a month ago and is in agreement with those abstracts.
- Ms. Montgomery is authorized to enter into a stipulation. She is waiting for any additional conversations to take place to approve a final stipulation.
- Ms. Ransom did not receive the latest abstracts. She does not anticipate disagreement after receipt.
- Mr. Murphy is aware of issue mentioned by Mr. Sparks and believes it can be resolved shortly and then the Community will most likely stipulate.
- Mr. Palmer is also waiting for any additional conversations to take place to approve a final stipulation.
- Mr. Sparks states that he does not believe it is appropriate, when before the Court, to refer to specific substantive issues discussed during settlement efforts and requests that all parties refrain from giving any information about specific issues discussed as part of a settlement of claimed water rights.

The Court inquires of Mr. Sparks about the amount of time he believes will be required to resolve the outstanding issue.

Mr. Sparks defers to Mr. Brown.

Mr. Brown has read the latest email from Mr. Sparks but not discussed it with his clients. His client may be agreeable to the latest offer and they may not need an expert. Mr. Brown will send the latest abstracts to Ms. Ransom.

The Court inquires of Mr. Brown how much time is still needed.

Mr. Brown states that February is agreeable.

Ms. Staloff has nothing further to add.

The Court will set a Status Conference in 60 days regarding the outstanding issues and the status of the case.
