Claimant received a response from the United States on November 14, 2023. Claimant circulated revised abstracts on November 29, 2023, and received timely responses from most objectors. As of the December 6, 2023, the filing date of their status report, the

1 Claimant had not received comments from Liberty Utilities (Bella Vista Water) Corp.
2 or the Tonto Apache Tribe. Claimant has requested an additional ninety (90) days for
3 negotiations.


4 **IT IS ORDERED** that Claimant file notice with this Court when revised
