
On February 1, 2023, counsel for Casa de la Orilla LLC filed a Status Report which stated that draft abstracts had been distributed to the parties by December 20, 2022. Salt River Project, ASARCO, the United States, and BHP Copper responded with either approval or comments. San Carlos Apache Tribe and Yavapai Apache Nation acknowledged receipt of the abstracts and stated that they would provide comments or approve upon completion of their

1 review. No responses were reported from the Gila River Indian Community, the Tonto
2 Apache Tribe or Liberty Utilities/Bella Vista Water. Counsel for Casa de la Orilla LLC
3 requested until April 3, 2023 to file a stipulation among the parties or a status report.


