Mr. Foy addresses the Court. SRP provided some technical comments to Mr. Brown and believes they are ready from SRP's standpoint.

Ms. Montgomery will propose a recommendation to the Yavapai-Apache Nation once she has a chance to receive and review the revised abstracts.

Mr. Murphy reports he has not received the revised abstracts.

Ms. Hermann has evaluated the revised abstracts and sent a letter to Mr. Brown today expressing their concerns.

Mr. Billingsley did not have any comments or concerns with the first round of abstracts but will evaluate the revised abstracts once he has received them.

IT IS ORDERED that Mr. Brown respond to Ms. Hermann's letter within 10 days and send the Court the stipulated abstracts or a status report within 30 days.
