24 the Court has received no further communication from the parties regarding the order of
25 documents from the National Archives or any other update.

26 This case was initiated on December 3, 2021 and was originally stayed due to the
27 closure of the National Archives on February 14, 2022. The Court has extended the stay
28 in this case and allowed counsel ample time to research and gather documentation to move

1 this case forward. It has been eleven (11) months since the parties have given any update
2 to the Court.


3 The Court, having an obligation to move the adjudication forward and resolve cases
