25 Archives or any other update.

26 This case was initiated on September 24, 2021, and was originally stayed due to the
27 closure of the National Archives on December 9, 2021. The Court has extended the stay
28 in this case and allowed counsel ample time to research and gather documentation to move


1 this case forward. It has been eleven (11) months since the parties have given any update
