18 DESCRIPTIVE SUMMARY: This order sets an **August 29, 2025**, deadline for property
19 owner Sunni Snow to file basis of right documentation. A status report from the Arizona
20 Department of Water Resources regarding filings for this contested case is due **December 1, 2025**.

22 On September 9, 2024, the Court initiated a case to determine water rights on
23 Cochise County parcel 208-10-014B.¹ As of December 6, 2024, ADWR reported that
24 “the claimant needs additional time to determine whether they want to take the necessary
25 steps to legally appropriate water.”² It appears that, as of February 24, 2025, Statement
26 of Claimant 39-6326 has been assigned to the current owner of parcel 208-10-014B.

27 **IT IS ORDERED** that property owner Sunni Snow shall file all necessary permit


