Eric Wilkins informs the Court that ASLD intends to pursue water rights in this matter, and discussion is held. ASLD has identified WRRA filing #36-5271 for SP004 and stockpond registration filing #38-88614 for SP003.

Mr. Wilkins also informs the Court that ASLD spoke to the lessee of the property, Scott Stratton with DOS S Land and Cattle LLC, and believes that the lessee has no issues with ASLD pursuing the water rights in this matter.

The Court directs ASLD to put together draft abstracts.

Further discussion is held regarding stockponds. Katrina Wilkinson states that SRP does not have any issues with proceeding with the draft abstracts and notes that many of the certificates that support some of the stockpond PWRs are still in the name of Bio Telles Ranch.

Mr. Wilkins states that ASLD intends to go forward with the pre-filing initially filed by ASLD relating to stockponds 1 through 5. The documents are in process relating to stockpond 6.

IT IS ORDERED that ASLD shall draft the abstracts and submit them to the Court on or before **December 9, 2024**. Objectors will have 30 days from December 9, 2024 to review the draft abstracts.

IT IS FURTHER ORDERED setting a status conference on January 9, 2025 at 10:00 a.m. for the purpose of discussing the draft abstracts.
