23 interest with the court by June 6, 2025. The court received communications from property
24 owners Gerald and Phyllis Nelson. The court has not received anything from property
25 owner Jared Madsen.

26 **IT IS ORDERED** scheduling a status conference hearing for **Thursday, August 21,**
27 **2025, at 10:30 am.** This conference will be held concurrently with contested case W1-

1 11-1538 as many of the documents and issues are the same. Property owners who fail to
2 attend this second status conference will be dismissed from the case and any potential
3 water rights associated with this contested case may be forfeit.
