

This contested case was initiated on February 10, 2025, to adjudicate a well located within the subflow zone of the San Pedro River. Twelve separate landowners were notified of this case. Lloyd, and Natalie Judd indicated these landowners would not be pursuing any potential water rights during an October 2, 2025 status conference. During that same status conference, landowners Kenneth A. and Karen L.
