In this case, Charles and Helen I. Harris (“Claimants”) filed Statement of Claimant (“SOC”) 39-11318 for rights to water for use on land in the northeast quarter of the northeast quarter of the northeast quarter of Section 32 Township 17S Range 21E. The Arizona Department of Water Resources (“ADWR”) investigated the claim, which it characterized as a claim for irrigation, domestic, and stock watering uses. It prepared a report known as Watershed


1 File Report No. 112-17-AC-054 (“WFR”) published in the Final San Pedro River Watershed
2 Hydrographic Survey Report (1991). The WFR found no irrigation, domestic or stock watering
3 uses on the land described in the WFR.

4 The Claimants have not appeared at any proceeding in this contested case. The public
5 records maintained by ADWR do not include a form of assignment of the Statement of Claimant
6 to any successor landowner. The only successor landowner who appeared at the proceedings in
7 this case to claim a water right was Christopher Winslow Hill. Mr. Hill was advised at the March
8 17, 2022 status conference that he needed to file a Statement of Claimant if he intended to assert
9 a claim for a water right. At the May 6, 2022 status conference Mr. Hill was again advised that
10 he needed to file a Statement of Claimant if he intended to assert a claim for a water right and
11 given 30 days to file the Statement of Claimant. As of July 18, 2022, the public records
12 maintained by ADWR do not contain a Statement of Claimant filed by Mr. Hill for the land
13 included within the WFR.


14 Accordingly,
