

18 This case was initiated on November 21, 2024, and an initial status conference
19 scheduled for January 7, 2025. Current property owners Sonia G. and Raymond A.
20 Preciado failed to appear at the initial status conference and were ordered to provide written
21 confirmation to the Special Master of their interest in pursuing any potential water rights
22 they may have February 7, 2025. On February 3, 2025, the Special Master received such
23 notice of interest from the Preciados. The notice was not properly filed with the Maricopa
24 County Clerk of Court or the full court approved mailing list for this contested case,
25 therefore the notice is attached to this order as Attachment A.

26 **IT IS ORDERED** setting a second status conference for **Tuesday, March 4, 2025,**
27 **at 10:30 a.m.** for claimants to explain their failure to attend the January 7, 2025,
28 conference, and determine the next steps in this contested case. If the Preciados fail to

1 attend a second conference, this case will be dismissed and any potential water rights
2 associated with this contested case will be forfeit. The conference will be held using the
3 Court Connect program. Instructions for Court Connect are attached as Attachment B. If


