20 On May 28, 2025, the Special Master received notice from property owners
21 Timothy Wilson and Seth Wilson confirming their timely submissions of documentation
22 to support a basis of right for their potential water rights claims. Both gentlemen stated
23 the Arizona Department of Water Recourses (“ADWR”) had informed them the agency
24 was backlogged, and it may take several months for their submissions to be fully
25 processed.

26 **IT IS ORDERED** that ADWR shall provide a status update when the filings have
27 been processed or by **December 1, 2025**, whichever comes sooner. If the filings have still

1 not been processed by December 1, 2025, ADWR will provide a deadline when
2 processing will be complete.
