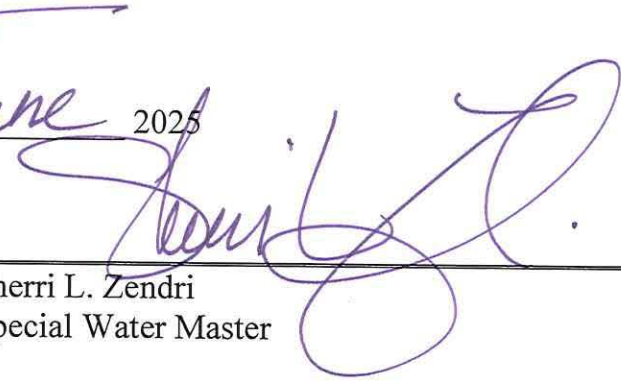
18 The Court, having reviewed the June 20, 2025, Joint Motion to Vacate and

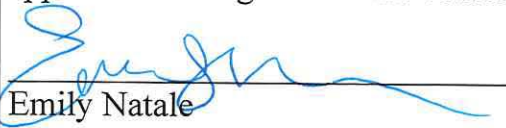
