DESCRIPTIVE SUMMARY: This order clarifies the status of abstract 111-24-CBB-003-SP001, the Court's mapping instructions to ADWR, and apparent inaccuracies in abstract 111-20-032-WL008 and the accompanying map.

**SOURCE** 

On December 5, 2024, the Court issued an Approval of Abstracts and Inclusion in the Catalog of Proposed Water Rights and Order to File Progress Schedules ("December 5 Order") in the above listed cases. This December 5 Order approved proposed abstracts for multiple state law water rights for the San Pedro Riparian National Conservation Area ("SPRNCA") and set an agenda for resolving remaining state law water rights in these cases. On December 13, 2024, SRP requested clarification regarding certain aspects of the Order. The Court responds to SRP's request for clarification regarding:

1. Whether the Court inadvertently requested comments for 111-24-CBB-003-SP001, an abstract that has already been approved.

- 2. Whether the Court inadvertently omitted from its December 5 Order maps submitted by the United States on October 10, 2024, for proposed abstracts 111-24-CCB-011-SP002, 111-24-CCB-011-SP003, and 111-24-CCB-011-SP006.
- Whether the Court inadvertently recorded the incorrect Point of Diversion and inadvertently included an incorrect map for abstract 111-20-032-WL008, approved in its December 5 Order.

### 111-24-CBB-003-SP001

The Court inadvertently stated that the abstract approval process is not complete for 111-24-CBB-003-SP001. The Court recognizes that an abstract was approved for this water right on October 28, 2024. W1-11-1344, Order Approving Proposed Water Right Abstract (Oct. 28, 2024).

**IT IS ORDERED** that the following language from page 11 of the Court's December 5 Order be struck:

"The Court issued a proposed abstract for 111-24-CBB-003-SP001 in May 2024. No party has provided corrections to this proposed abstract. IT IS ORDERED that any suggested corrections for 111-24-CBB-003-SP001 must be filed by January 7, 2025."

### Maps for 111-24-CCB-011-SP002, SP003, and SP006

The Court recognizes that the United States submitted proposed maps for water rights 111-24-CCB-011-SP002, 111-24-CCB-011-SP003, and 111-24-CCB-011-SP006. W1-11-232, United States' Notice of Filing Corrected Abstracts (Oct. 10, 2024). The Court also recognizes that no party has objected to these maps. Nonetheless, the Court

instructed Arizona Department of Water Resources ("ADWR") to prepare maps for these rights by January 7, 2025. December 5 Order at 6.

The Court instructed ADWR to prepare maps for the above uses for the sake of consistency and ease of administration. Simply put, limiting the number of entities producing maps will minimize future questions regarding interpretation of the maps. Still, in creating the above maps, ADWR shall consider the proposed maps submitted by the United States. Further, ADWR shall seek clarification from the United States where the place of use or point of diversion is unclear.

## 111-20-032-WL008

In the Court's December 5 Order, the abstract for 111-20-032-WL008 and the map accompanying that abstract are inaccurate. December 5 Order at PDF 14–15. The Point of Diversion should read "NESESW Section 20 T21S R22E" rather than "NESESW Section 29 T21S R22E." *Id.* at PDF 14. A corrected abstract is attached as Attachment A to this order.

The map accompanying the abstract included in the Special Master's order is also incorrect. ADWR shall create a map to accompany the abstract based on the map for 111-20-032-WL008 submitted in the United States' October 10, 2024, filing.

**IT IS ORDERED** adding to the Catalog of Proposed Water Rights the corrected abstract for 111-20-032-WL008.

**IT IS ORDERED** that ADWR shall create a map to accompany the abstract for 111-20-032-WL008.
