The Court provides the purpose and background for these proceedings to the Clarks.

Mr. Clark states that he has two wells; an irrigation well and a domestic well. A third property adjacent to the two 40-acre parcels also has a well on it. He confirms that all three wells are registered with the Arizona Department of Water Resources. The adjacent parcel is north of his property.

The Court further explains to Mr. Clark what needs to happen to establish a water right and recommends that Mr. Clark contact the Arizona Department of Water Resources ("ADWR") to review the Statement of Claim. The Court will provide additional information and guidance regarding next steps as a "LATER" to this Minute Entry.

For the reasons stated on the record,

IT IS ORDERED setting a virtual/telephonic Status Conference to discuss updates and how to further proceed on Thursday, October 16, 2025 at 10:00 a.m. in this division before Special Water Master Sherri Zendri. The status conference will be held using the Court Connect program. Instructions for Court Connect are attached as Attachment A. If you receive this Order by email, click on the red box "Join Court Connect Hearing" on the attached instructions to make an appearance. LATER

To pursue water rights, Mr. Clark must 1) file a Statement of Claimant, and 2) present to the Court evidence of a legal right to the water claimed on the Statement of Claimant, this is often referred to as a Basis of Right. If Mr. Clark proves to the Court the existence of a legal water right on his property, the Court can recognize enforceable

water rights in a "Final Decree." ARS § 45-257(B). In Arizona, water subject to the General Adjudication includes surface water and certain subsurface water referred to as "subflow." Subflow is underground water that is hydraulically connected to a stream and is considered part of the surface stream. Wells pumping subflow are subject to the same rules of appropriation as the surface stream itself. Development of the subflow zone for any particular Arizona river system is a multiple year endeavor completed by the Arizona Department of Water Resources (ADWR) with cooperation from the Arizona Geological Survey. The April 2014 Revised Subflow Delineation for the San Pedro River, as well as documents prepared by the ADWR as part of the November 1991 Hydrographic Survey Report ("HSR") and can be found on the ADWR website at:

to set up a meeting. **This meeting must occur no later than October 10, 2025**, and will help Mr. Clark review her Statements of Claimant and update where necessary and provide guidance to Mr. Clark regarding the appropriate forms to apply for legal authorization to use water, also known as the "basis of right," is presented to the Court.

Statement of Claimants (SOCs)

A SOC is a landowner's or lessee's ("claimant's") written statement to the Court that provides details about their water right claim. This claim to use public water is filed with the Arizona Department of Water Resources ("ADWR"). Although a water right generally remains attached to the land, the SOC must reflect the current claimant's name and contact information as well as any changes to the original claim. The SOC as filed may not accurately list current landowners and water uses. To update an SOC, Mr. Clark may make an SOC amendment, obtain a SOC assignment from the original claimant, or file a new SOC for the use. See Ariz. Rev. Stat. §§ 45-254. Basis of Right

To obtain a water right, Mr. Clark must also provide a "basis of right." To begin this process, Mr. Clark must file a document with ADWR either registering a water right, applying for a permit to appropriate water, or applying for a stockpond claim of right. See Arizona Revised Statutes ("Ariz. Rev. Stat.") §§ 45-182(A), 45-152(A), 45-273.

If Mr. Clark proves that the water right claimed was initiated prior to June 12, 1919, he does need to file an "application for a permit to appropriate," but must present a statement of claim registering their claimed water right. See Ariz. Rev. Stat. §§ 45-171, 45-182(A). Note that a statement of claim is a different document than a statement of claimant.

Because of the time and cost involved in pursuing an "application for a permit to appropriate public water" or an "application for a stockpond claim of right," claimants should first gather as much evidence as possible to determine which, if any, of their water rights claims are for water uses initiated prior to June 12, 1919.

Federal land entry case files (e.g. homestead proofs and affidavits) may be useful for proving historical farming and grazing activity on your land. Resources for finding land entry filings are listed below:
