18 appear.

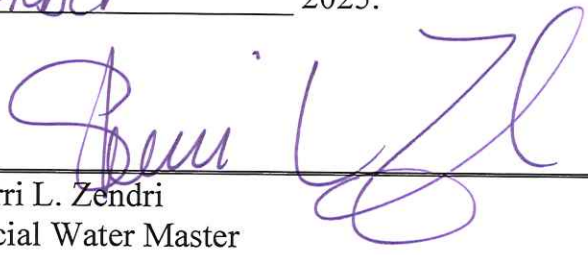

20 In a letter received April 18, 2025, by the Office of the Special Master, property
21 owner Robert Allen Buzan Jr. indicated he was interested in pursuing potential water
22 rights for his property associated with this contested case. Therefore, a May 6, 2025,
23 Order from the Special Water Master required that Mr. Buzan file, by June 30, 2025,
24 any appropriate amended statements of claimant for stockpond and /or domestic water
25 use and any appropriate basis of right documentation to substantiate his claims.
26 Further, Mr. Buzan was required to notify the Court by July 14, 2025, of any of these
27 filings. As of the date of this order there have been no filings from Mr. Buzan.

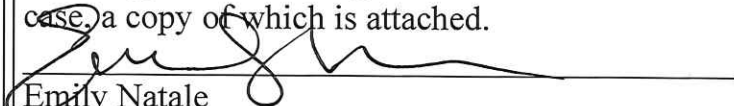
28 **IT IS ORDERED** dismissing Statements of Claimant 39-6427 and 39-12432.
