**LET THE RECORD REFLECT** the United States is not present.

Ms. Dykes provides the Special Master with an update regarding her meeting

with the Arizona Department of Water Resources ("ADWR"). Ms. Dykes states that she has two artesian wells on the property that both flow into a pond. Both wells are registered and used for irrigating the garden, livestock and residential. Ms. Dykes indicated she was a little unclear on how to properly fill out the statement of claimant ("SOC") form for the ponds since they don't meet the definition of a stockpond.

The Special Master suggests another meeting between Ms. Dykes and ADWR to complete the next steps in this process:

- 1. Ms. Dykes works with ADWR to ensure the Statements of Claimant are current and accurate.
- 2. ADWR shall assist Ms. Dykes with putting together the basis of right for her potential water right

## LATER:

IT IS ORDERED that ADWR contact Ms. Dykes and schedule another meeting to occur no later than **December 31, 2025**. ADWR can contact the Office of the Special Master for Ms. Dykes phone number if the agency does not have it. This meeting should include a discussion with Ms. Dykes regarding her options for a basis of right for her potential water rights.

IT IS FURTHER ORDERED that ADWR shall file a meeting summary within 10 business days of the meeting Ms. Dykes. The summary shall include an estimated time frame for ADWR to complete processing of any filings from Ms. Dykes. Once the Special Master receives this summary, the parties will be notified of next steps through a separate order.
