22 On October 18, 2023, counsel for Roots Investments LLC filed a Status Report in  
23 this case. That Status Report addressed the continuing delay of documents that had been  
24 previously ordered from the National Archives. The status report also stated that if the  
25 documents had not been received from the National Archives within sixty (60) days of  
26 filing, counsel would seek to obtain the necessary records through another avenue. Sixty  
27 (60) days have long since passed, and the Court has received no further communication  
28 from the parties regarding the order of documents from the National Archives or any other  
update.

1 This case was initiated on October 18, 2019, and was originally stayed due to the  
2 closure of the National Archives on June 14, 2021. The Court has allowed counsel ample  
3 time to research and gather documentation to move this case forward. It has been eleven  
4 (11) months since the parties have given any update to the Court.

5 The Court, having an obligation to move the adjudication forward and resolve cases  
6 expeditiously,

7 **IT IS ORDERED** that counsel for Roots Investments LLC file by **December 23,**  
8 **2024**, a draft abstract(s), along with any necessary documentation, or a proposed trial  
9 schedule. Should claimants fail to meet the deadline this case will be dismissed unless  
10 good cause can be shown otherwise.
