9:31 a.m. This is the time set for a Status Conference to determine whether the property owners are interested in pursuing water rights before the Special Water Master Sherri Zendri.

The Court notes that it has not received any notice of interest for two of the five cases being held today. Ms. Castro indicates that her parents are interested in water rights for all five cases but did not understand that they needed to send that Notice in.

The Court inquires what water is being used and for what use.

Ms. Castro explains that some properties have fire damage from about five years ago and the wells on those properties are not in use. There are three wells that are being used for domestic use and watering the few trees on their property.

The Court addresses the property owners regarding the purpose of this proceeding.

Mr. Garcia states that some of his wells were registered but at that time he did not own the Chester or Hickson properties and he is unsure if those were previously registered by someone else.

The Court explains that the property owners will need to accomplish the following:

- 1. Register the wells in use
- 2. File their Statement of Claimant for each property
- 3. Provide basis of right
- 4. Address any objections filed to the original claims

The Court encourages the parties to obtain documentation regarding the historical use of water on the properties. If the wells are post June 1919, it is likely that they will need to get a permit. The parties may reach out to ADWR for assistance in locating the registration and permits in the event that they are not able to locate the historical documentation.

Mr. Garcia states that they just purchased another property on June 6th across the street from the Daniels' property and provide the following parcel number: 300-26-04506.

The Court will research this parcel to see if it was included in ADWR's original investigation and whether it is appropriate to include.

The Court addresses the parties regarding objections. The Court will include a link in today's minute entry so the parties can review the original objections along with contact information for ADWR. The Court encourages the parties to meet with ADWR at which time they will report back to the Court. The Court will then determine the next steps in this matter and send a notice out to the parties by mail.
