5 IT IS ORDERED that Ms. Romero-Sims will contact the Ariona Department of 6 Water Resources ("ADWR") Adjudications Section at (866)-246-1414 and schedule a virtual meeting no later than October 1, 2025, for ADWR to help Ms. Simms update her 7 8 Statement of Claimant and understand her options for a valid basis of right.

9 IT IS FURTHER ORDERED setting a status conference for Thursday, October, 2, 2025, at 11:00 am for Ms. Romero-Simms to tell the Special Master what 10 11 basis of right she intends to pursue and what steps she has taken to begin the process of 12 obtaining that basis of right.

13 Should Ms. Romero-Simms fail to meet with ADWR, or attend the October 2, 2025, status conference, Statement of Claimant 39-2402 shall be dismissed and all 14 15 proceedings in this case terminated.
