DESCRIPTIVE SUMMARY: Order setting a status conference for **Thursday, January 9, 2025, at 10:30.**



On July 12, 2024, claimant Ms. Romero-Simms was ordered to file with the Court a status report no later than Friday, August 30, 2024, that included, among other information, an explanation why Ms. Romero-Simms failed to attend the June 26, 2024, meeting scheduled by the Arizona Department of Water Resources (ADWR) to assist her, and an estimated schedule of how long it will take Ms. Romero-Simms to complete any filings needed for a basis of right for her claim. Ms. Romero-Simms failed to file any status report nor has Ms. Romero-Simms reached out to ADWR for any assistance.

IT IS ORDERED setting a status conference for Thursday, **January 9, 2025, at 10:30** for a final opportunity for Ms. Romero-Simms to present evidence regarding her water right claim. Should M. Romero-Simms not attend the conference, or not have

1 documentation of substantial progress towards obtaining evidence to support her water
2 right claim, this case will be dismissed.
