
On October 10, 2022, an Order to Initiate Contested Case was issued to resolve objections to Watershed File Report 114-04-BAB-38 prepared by Arizona Department of Water Resources ("ADWR") that described domestic and irrigation water uses on the southeast quarter of Section 8 Township 6S Range 16E. Notice of the proceedings was given to the Winkelman Resource Management Center and the trustees of the Marty and Donna Woods Living Trust. On November 17, 2022, a Status Conference was held to determine whether the current owners of the land that was the subject of ADWR's investigation intended to assert claims for rights to appropriable water for use on the land. No landowner appeared at the Status Conference. The

1 landowners were given until December 19, 2022, to file or have a legal representative file a notice
2 of appearance indicating an intention to proceed. No filings were made by or on behalf of the
3 landowners by December 19, 2022 or to date. Accordingly,

4 **IT IS ORDERED** dismissing this contested case and no further action will be taken with
5 respect to Watershed File Report 114-04-BAB-38 or with respect to any claims for rights to water
6 for use on the land investigated by Watershed File Report 114-04-BAB-38.
