The Court notes that Mr. Robert Floyd, the landowner/claimant, is not present for today's Status Conference. The Court had certain matters to discuss with Mr. Floyd, including the well registration, Statement of Claimant, working on the Basis of Right and Quantity of Use issues.

Karen Nielsen from ADWR informs that Court that she has been in fairly close contact with claimant, Robert Floyd, and has been assisting him with his claims.

LET THE RECORD REFLECT that Mr. Floyd is required to be present virtually / telephonically at all future conferences in order to continue to pursue his claims.

LATER:

In the May 30, 2024, Minute Entry, the Court rescheduled a status conference as a result of landowner/claimant Robert Floyd's failure to attend and provide the Court an update. The Minute Entry further informed Mr. Floyd that failure to attend a second status conference will result in the dismissal of his potential claims for this contested case. Mr. Floyd did attend the rescheduled conference on July 2, 2024, explained that his previous failure to attend was due to health issues, and reiterated to the Court his interest in pursuing any potential water right(s).

For this most recent status conference, Mr. Floyd again failed to attend. However, the ADWR notified the Court that Mr. Floyd is in fact moving forward with the necessary actions to resolve his potential water rights. Recognizing that Mr. Floyd may have continued health issues, the Court will extend him more time. Therefore,

IT IS ORDERED that that by **October 11, 2024**, Mr. Floyd shall file with the Court a written statement explaining his failure to appear for a second time on September 10, 2024, and provide to the Court an update of his progress regarding updated SOCs and basis of right of application(s), and a detailed explanation of the quantity of use he is claiming. This is the final opportunity for Mr. Floyd. Failure to provide the documentation as ordered by the Court shall result in the dismissal of Mr. Floyd's potential claim.
