21 Pursuant to an October 3, 2024, order from this court, the Arizona Department of  
22 Water Resources ("ADWR") filed a revised watershed report and draft abstract for this  
23 contested case on February 5, 2025. Objections to the WFR and comments to the draft  
24 abstract were timely filed by the Salt River Project<sup>1</sup>, BHP Copper, and the San Carlos  
25 Apache Tribe.



27 <sup>1</sup> "Salt River Project" refers collectively to the Salt River Project Agricultural Improvement and Power District, and  
28 the Sat River Valley Water Users' Association.

1 Given ADWR's lengthy processing time for a permit, and noting that proceedings  
2 are in process for other contested cases where the final decisions may affect this  
3 contested case,

4 **IT IS ORDERED** staying contested case W1-11-3112 until decisions are made  
5 for W1-11-0245 - *In re Town of Huachuca* and W1-11-1511 - *In re ASLD – Fred and*  
6 *Carol Telles*.

7 **IT IS FURTHER ORDERED** that ADWR shall file a status report on or before  
8 **October 3, 2025**, regarding the processing of Mr. Floyd's permit.
