IT IS ORDERED granting the substitution of counsel.

The Arizona Department of Water Resources provided an updated map detailing the parcels investigated as part of WFR #114-04-BAC-019 which depicted ownership of the northern parcel by the Arizona State Land Department (ASLD) and the southern parcel by the United States Bureau of Land Management (BLM).

The United States Bureau of Land Management and Arizona State Land Department were ordered to file evidence of an appropriate SOC and a basis or right for a potential water right claim regarding their respective parcels.

LET THE RECORD REFLECT that neither the ASLD nor the BLM will be pursuing a claim for water rights on the property. Accordingly,

IT IS ORDERED dismissing this case. The WFR is closed, but the Statement of Claimant is not dismissed because it is a part of another case.

To clarify, Statement of Claimant 39-004966 is also part of another contested case still in process and will remain open.
