On October 18, 2023, counsel for Harriet Hedrick and Beverly Meade Miller filed a Status Report in this case. That Status Report addressed the continuing delay of documents that had been previously ordered from the National Archives. The status report also stated that if the documents had not been received from the National Archives within sixty (60) days of filing, counsel would seek to obtain the necessary records through another avenue. Sixty (60) days have long since passed, and the Court has received no further communication from the parties regarding the order of documents from the National Archives or any other update.

This case was initiated on December 19, 2019, and was originally stayed due to the closure of the National Archives on June 21, 2021. The Court has extended the stay in this case multiple times and allowed counsel ample time to research and gather documentation to move this case forward. It has been eleven (11) months since the parties have given any update to the Court.

The Court, having an obligation to move the adjudication forward and resolve cases expeditiously,

Should claimants fail to meet the deadline this case will be dismissed unless good cause can be shown otherwise.
