21 dismissed cases.

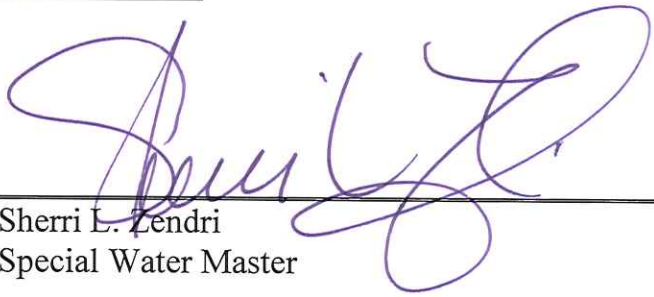

23 The office of the Special Water Master maintains a website that includes current
24 Court Approved Mailing Lists ("CAMLs") for most cases. Prior to this Notice, that
25 website included the Court Approved Mailing List for many cases that have been
26 dismissed. Although it is a possibility, the chance of a motion being filed in one of these
27 cases is fairly low. Due to the effort, both on the part of the Office of the Special Water
28 Master in keeping these CAMLs updated online, and the effort of the parties in filing
notices of substitution in cases that are long since dismissed, the Office of the Special Water
Master will no longer publish or upkeep CAMLs for dismissed cases. Should a party have

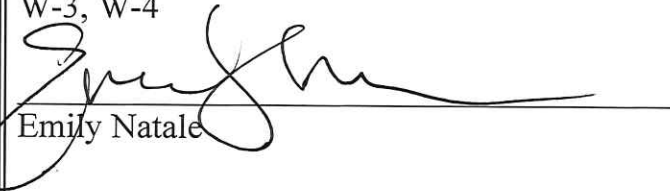
1 a need to file a motion in a dismissed case they may contact the office of the Special Water
2 Master to obtain a copy of the last Court Approved Mailing list that was used in the case.

3 It should be noted that cases that have proposed water right abstracts included in the
4 Catalog of Proposed Water Rights created pursuant to §15 of the Rules for Proceedings
5 Before the Special Master will continue to have CAMLs maintained and posted online.
6 This is due to the additional adjudication before the water judge that will occur before a
7 final decree can be issued.
