Discussion is held regarding the objections to the recent maps created by the Arizona Department of Water Resources. Based thereon,

**IT IS ORDERED** the Arizona Department of Water Resources shall provide supplemental subflow technical reports by **February 13, 2015**. Any supplements or withdrawals to objections shall be submitted by **April 2, 2015**.

**IT IS FURTHER ORDERED** setting an in-person hearing for **April 23, 2015 at 9:30 a.m.** (time allotted: 1 day) in this division to resolve remaining objections to the

supplemental subflow technical reports. Counsel shall meet and confer between April 2, 2015 and April 22, 2015 to discuss the supplemental subflow reports.

Oral argument is presented on SRP's Motion to Designate a Contested Case on Verde River Subflow.

Oral argument is presented on the City of Cottonwood's Motion to Designate Contested Case to Determine the Water Rights of the Yavapai-Apache Nation.

Oral argument continues on the City of Cottonwood's Motion to Designate Contested Case to Determine the Water Rights of the Yavapai-Apache Nation.

The court opens the floor to other topics. Cone of depression testing and the Steering Committee are discussed.

The Arizona Department of Water Resources offers to come up with a proposed general game plan for the first six months.

**IT IS ORDERED** taking SRP's Motion to Designate a Contested Case on Verde River Subflow and the City of Cottonwood's Motion to Designate Contested Case to Determine the Water Rights of the Yavapai-Apache Nation under advisement.

**LATER:**

Regarding SRP's motion to designate a contested case regarding Verde River subflow, the court agrees that the Verde River is an appropriate "next stop" for the Department of Water Resources' attention, and that the Department should begin work on that basin as its resources permit. The court believes that the Department's work, however, should continue to focus on the goal of completing the adjudication regarding the San Pedro River, both in terms of completing the delineation of the subflow zone and in creating cone of depression testing. This work on the San Pedro River takes priority over work on the Verde River. And, the court does not believe that the creation of a contested case is a prerequisite to the Department beginning work on the Verde River subflow.

Regarding Cottonwood's Motion to Designate a Contested Case to Determine the Water Rights of the Yavapai-Apache Nation, the court believes that such is premature because the Department's limited resources are better deployed elsewhere at this juncture.
