The Navajo Nation reported on December 15, 2010, concerning the progress of the water rights settlement known as the Northeastern Arizona Indian Water Settlement Agreement and its position that the Arizona Department of Water Resources ("ADWR") continues working on the Final Hopi Indian Reservation Hydrographic Survey Report ("Final HSR"). The Navajo Nation has requested that the suspension of the pending deadlines in this contested case be continued until at least April 13, 2011, which is the expiration of the federal district court's stay concerning the Colorado River litigation.

The Hopi Tribe supports the Navajo Nation's position that ADWR should

continue to work on the Final HSR. The Catalyst Paper (Snowflake) Inc. company recommends determining what work ADWR can complete given its fiscal situation.

The Special Master will continue the suspension of the pending deadlines and will hold a telephonic conference on April 19, 2011, to review the status of the proposed settlement agreement and ADWR's work schedule. If this case is stayed, the Special Master wants to discuss what other issues and matters can or should be taken up in this adjudication.

IT IS ORDERED:

- 1. Setting a telephonic conference on **Tuesday, April 19, 2011, at 9:30 a.m.** (**MST**) to discuss the matters described above. - 2. Directing ADWR to be prepared to explain how preparation of the Final HSR will fit within its anticipated budget and work schedule and make any recommendations it deems best, and,
- 3. Requesting the parties to be prepared to discuss what other issues and matters can or should be taken up in this adjudication if this case is stayed.
